# Discrimination is forbidden!



**Discrimination** is the **disadvantageous treatment** of a person because of certain **characteristics**:

- sex /gender
- ethnicity or skin colour
- religion or belief
- age
- sexual orientation

**Harassment** is also a form of discrimination.

## Discrimination happens for example

- when a 55-year-old doesn't get a job because he is "too old"
- when a woman wearing a headscarf is being insulted at work
- when a man loses his job because he is homosexual
- when a family cannot rent an apartment because they come from abroad
- when a woman is being groped by her doctor
- ...
